Abstracts are now being accepted for the Caribbean Regional Conference of Psychology, CRCP2011, which takes place in Nassau, Bahamas, November 15-18. **4. Wilhelm Wundt - William James Award for exceptional contributions to trans-Atlantic Psychology**

Nominations are invited for the Wilhelm Wundt - William James Prize, which recognizes psychologists who have made distinguished contributions to the science and profession of psychology and to the promotion of effective cooperation between Europe and North America. The Award is given in alternate years to a North American or European psychologist. In 2007 the recipient was a European psychologist and in 2009, a North American psychologist. The award will be presented at the opening ceremony of the biennial Congress of the European Federation of Psychology Associations (EFPA) in Istanbul in July 2011.
