IJP: STRENGTHENING ACCESS FOR COUNTRIES IN NEED



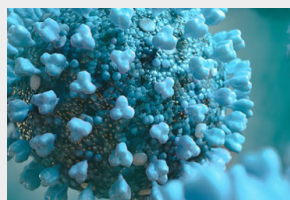
Many low-income countries do not have the funding to access published research, even though this content might help improve their quality of life. One of the ways that Wiley bridges this gap is to make the International Journal of Psychology's (IJP) research accessible to researchers across the globe through its partnership with **Research4Life**. This initiative provides researchers from low-income countries with free or low-cost access to the journal. Currently, over 6,700 institutions from 87 countries, areas, and territories have online access to IJP's current content through this partnership.

In 2002, Wiley was active in launching **HINARI**, a public-private program involving six leading medical publishers in collaboration with the World Health Organization. Its aim was to bring online access to peer-reviewed research to researchers and physicians in the world's poorest countries. Today, HINARI is just one of five programs in the **Research4Life** initiative: Research in Health (HINARI), Research in Agriculture (AGORA), Research in the Environment (OARE), Research for Development and Innovation (ARDI), and Research for Global Justice (GOALI). To access research materials, countries, areas, and territories are classified into either Group A or Group B with access to the programmes either free or at very low cost. The list of Group A and Group B countries, areas, and territories is **available on the Research4Life website**. The Research4Life Capacity Development working group also delivers face-to-face workshops and standardizes curricula to ensure the effective use of research materials available in the participating libraries. In addition, there is a UN project with Research4Life to promote digital access to research (DAR).

Wiley is also a close partner with the International Network for the Availability of Scientific Publications (**INASP**), which delivers access to all of our online journals, including IJP, at a reduced price to countries in Africa, Asia and Latin America.

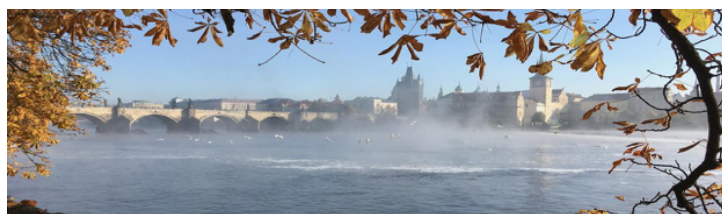

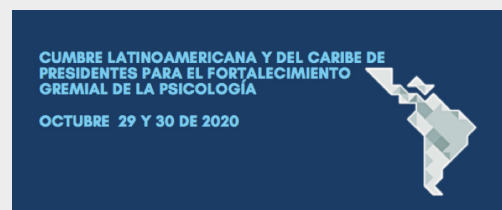
TURKISH PSYCHOLOGICAL ASSOCIATION: AWARDS ANNOUNCEMENT



In honour of the late Sakıp Sabancı, Honorary Chairman of the Board of Trustees of Sabancı University, the Sakıp Sabancı International Research Awards are given each year in the field of social sciences. This year's theme is *Post-corona World and Turkey: Social, Psychological and Political Impacts of the Pandemic*.

The Sakıp Sabancı International Research Award involves a Jury Prize of USD 25,000 USD. The Jury Prize will be awarded to an individual who has made distinguished contributions to the above-mentioned theme. An independent and international jury will select the Awardee. In addition to the Jury Prize, Essay Awards will be given to researchers under 45 years of age. LATIN AMERICAN AND CARIBBEAN SUMMIT OF PSYCHOLOGY ASSOCIATIONS



Psychology in Latin America and the Caribbean has shown fast growth and has become a highly regarded profession. Indicators of this trend include an increase in the number of training programs, a rising demand for services on both traditional and emerging fields of psychology, a consolidation of professional and scientific organisations, and an accelerated expansion in publications, among others.

With over one million psychologists in the region, some of the challenges have been the large variability in the quality of training and professional services, a need to better define professional boundaries and unregulated professional action in some countries, and low wages despite the high social recognition.

IUPsyS has supported Capacity Building Programs in the region since 2015, promoting an ongoing dialogue and specific actions with national and regional organisations such as **CANPA**, **SIP** and **UCCAP**. In 2020, seven national associations organised the Latin American and Caribbean Summit of Psychology Associations, on 29-30 October 2020, under the auspice of IUPsyS. Representatives participated from Argentina, The Bahamas, Barbados, Bolivia, Brazil, Chile, Colombia, Costa Rica, Cuba, Ecuador, El Salvador, Guatemala, Honduras, Jamaica, Mexico, Nicaragua, Panama, Paraguay, Peru, Puerto Rico, Uruguay and Venezuela.

The opening lecture was delivered by Francisco Morales Calatayud (Cuba). He presented the main developments of psychology in the region, including an emphasis on clinical approaches to mental health and wellbeing. The common threads of this lecture were psychology's contributions to human rights, and the role of governments as providers of health in all its forms, as a common good to society.

A session titled Cooperation, innovation and regional impact promoted a scene for inter-institutional cooperation. A need to engage in strategic issues particularly in the field of advocacy emerged as an important goal. A plenary discussion identified essential thematic areas to be collaboratively undertaken: ethics and deontology; inequalities and violence; advocacy strategies in public policies; permanent training and certification processes; intrusiveness and working conditions; and the issue of evidence-based research.

The session on psychology and mental health in the region included the lecture by Germán Gutiérrez (Colombia) which summarised the ways psychology organisations around the world addressed the COVID-19 health crisis including different areas and levels of action, as well as strategies to work with governments, international organisations and NGO's. National organizations had the opportunity to share their programs regarding emergency responses within their countries as well as initiatives that promote inter-institutional cooperation. The Observatory of Psychology in Latin America, a regional project led by Colpsic and Ascofapsi, and sponsored by the IUPsyS, was also presented. This project is considered to be critical to inform and promote the integration of actions among the organisations in the region.

A joint declaration included priorities and commitments such as promoting alliances between countries, activities to influence public policy; sharing good practices in psychology and from an ethical standpoint; and supporting the Observatory of Psychology in Latin America. A key outcome of the Summit was the creation of a coordinating task force for the region to follow up on the proposed actions and activities.

THE UN RESEARCH ROADMAP FOR THE COVID-19 RECOVERY

Earlier this year, various organisations from across the world were invited to share their thoughts in order to assist informing COVID-19 recovery towards the Sustainable Development Goals (SDGs) in the frame of a task force led by the Canadian Institutes of Health Research to develop a 'UN Research Roadmap for the COVID-19 Recovery'. The Roadmap was recently published and the report identified 25 key research priorities to inform the socio-economic recovery from the current pandemic and accelerate progress towards the SDGs. WORLD CHILDREN'S DAY – AND MY HERO IS YOU

World Children's Day was first established in 1954 as Universal Children's Day and is celebrated on 20 November each year to promote international togetherness, awareness among children worldwide, and improving children's welfare. November 20th is an important date as it is the date in 1959 when the UN General Assembly adopted the **Declaration of the Rights of the Child**. It is also the date in 1989 when the UN General Assembly adopted the **Convention on the Rights of the Child**.

In April during the early stages of the pandemic, the WHO and partners released **My Hero is You, How kids can fight COVID-19!** - a storybook for 6-11-year-olds explaining how children can protect themselves, their families and friends from coronavirus and how to manage difficult emotions when confronted with a new and rapidly changing reality. Subsequently the book has been translated into 131 languages and has reached tens of thousands of children through numerous video and audio adaptations. JACOBS FOUNDATION RESEARCH

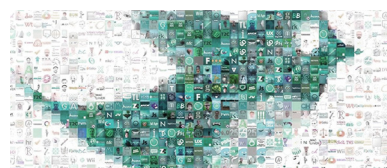

The Jacobs Foundation Research Fellowship Program is a globally competitive fellowship program for early and mid-career researchers whose work is dedicated to improving the development, learning and living conditions of children and youth. Fellowships are awarded to highly talented and innovative early and mid-career researchers who have received their PhD within the past 10 years. Funding from Jacobs Foundation Research Fellowships is awarded directly to the fellow's institution and may be used by the fellow over a three-year period to cover a portion of the fellow's salary and for any purpose in support of the fellow's research, such as assistants' salaries, equipment, technical assistance, professional travel, or trainee support.
