


FINAL ANNOUNCEMENT: 4th INTERNATIONAL WORKSHOP ON PSYCHOLOGICAL INTERVENTION AFTER DISASTERS, NOVEMBER 9–12, 2015 TAIPEI, TAIWAN



In the last decade, more than 40% of the natural disasters around the world occurred in the Asia-Pacific region, causing untold damage, loss of life, and hardship. The majority of countries in this region often lack an advanced infrastructure or responsive rescue systems. This will be the fourth in the series of workshops for the Asia-Pacific region first organised in 2012 and held annually since then. It employs international scientific and applied expertise to help researchers, educators and practitioners in the Asia-Pacific region have a better understanding of and ability to respond to the mental health consequences of disasters in the region. This workshop focuses on the psychological dimensions of response to and assistance after disasters. The deadline for submission of applications is 15 August 2015. BELGIAN ASSOCIATION FOR PSYCHOLOGICAL SCIENCE



The Belgian Association for Psychological Science (BAPS) was founded in 1946 following the initiative of the Belgian experimental psychologist, Albert Michotte. The aim of the Association was and still is to unite all those interested in the development of psychological science and its applications in Belgium. The Association seeks to encourage the exchange of ideas, to inform the community about developments in psychological science, and to offer its members opportunities for further specialized training. This is mainly achieved through its official journal, Psychologica Belgica, and through the organization of a yearly scientific meeting.

Psychologica Belgica publishes peer-reviewed, fully open access, scientific contributions from all domains of psychology. The Editorial Board members come from a wide range of psychology domains, working in Belgium and in other countries. Each year, the BAPS coordinates the organisation of its annual scientific meeting with the aim to integrate different approaches in psychology, to give the opportunity to researchers to disseminate the results of their research via symposia, open talks and posters, and to foster debates and discussions amongst researchers. The meeting includes communications by senior researchers via invited symposia and a keynote talk, but special attention is also given to more junior researchers via, for example, a Best Masters Thesis Award and three Best Poster Awards. The meeting usually includes around 150 communications attracting both national and international participants.

SINGAPORE PSYCHOLOGICAL SOCIETY

The Singapore Psychological Society (SPS) was founded in 1979 and has as its aim the advancement of psychology as a science and as a profession in Singapore.

The specific functions of SPS are as follows:

- To promote and disseminate knowledge in psychology and its applications for the benefit of the individual and society.
- To promote psychological research and organise meetings on matters in particular fields of psychology.
- To advocate, set up and maintain high standards of professional standing and conduct for its members in respect of the teaching, researching or practicing of psychology.
- 4. To disseminate information about opportunities for professional work, and to make recommendations from time to time to members and to employers about desirable qualifications and remuneration.
- 5. To safeguard the professional interests of members and to support all legitimate efforts to extend the knowledge and professional expertise of members, whether by research, encouragement of the publication of reports, documents or books on psychology, by facilitating access to relevant material, or by any other legal means.
- To liaise with organisations of psychologists elsewhere and with societies representing other professions, and to foster good relations with the public.
- 7. To lay down the requirements for membership of the Society and to maintain a register of members with details of their addresses, qualifications, appointments and experience.
- To do all that may be necessary and proper to protect the individual or general public against unsound practices.
