1. IUPsyS awarded funding from the ICSU Grants Programme

The International Council for Science (ICSU) is supporting a new IUPsyS project on Building Capacity for Psychological Intervention after Disasters in the Asia and Pacific Region. The project seeks to develop the capacity of researchers, educators and practitioners in the region to better understand and respond to the mental health consequences of the aftermath of regional disasters, based on international scientific and applied expertise. It will include a four-day expert workshop leading to recommendations on scientific development, training and infrastructure. The workshop will address a range of topics, including: training of students for cross-national research; building infrastructures to support cross-national research; building cultural competence; data sharing protocols; protection of human subjects in international research; capacity-building in host countries; financial support of cross-national research.
