#### 1. IUPsyS portal: Psychology Resources around the World

Over the past two years, the Union has been developing its web portal, Psychology Resources around the World. The portal was launched at ICP2012 in Cape Town, and its content has been growing since then. It includes information on psychology organizations, structures, and resources in every country in the world; overviews of regional, global psychology, conferences, networks and events; resources for teaching, research, service and application; links to codes of ethics, constitutions, data archives and portals, interest groups, and other reference material. #### 2. Workshops to consider the formation of the Pan-African Psychological Union (PAPU)

At the ICP 2012 Opening Ceremony, the leadership of various African psychology associations and IUPsyS announced the Cape Town Declaration, committed to establishing PAPU. The first PAPU workshop will be held at the University of Ghana, Legon (Accra) on 26-27 April, intended to involve psychology associations in West and North Africa. It will be followed by a second workshop in Johannesburg, South Africa, in September (intended for Southern African psychology associations) and a third in Kampala, Uganda in November (intended for East and Central African psychology associations in November 2013). #### 9. Winner of American Psychological Association's International Book Award announced

The Ursula Gielen Global Psychology Book Award was established in 2007 to recognize authors or editors of a book that makes the greatest contribution to psychology as an international discipline and profession. The recipient of the 2013 Award is Ervin Staub for his book Overcoming Evil: Genocide, Violent Conflict, and Terrorism. This book provides a broad overview of Dr. Staub's seminal life-work on the origins and prevention of genocide and violent conflict, and how to promote peace.
